





### 1. ICMS - IMWG


- 1. Does your team have enough experience to collect data and use the ICMS dashboard?
  - Yes, teams feel they have sufficient experience to be proficient, although more training would be welcome.
- 2. Would having a 1/2 or full day ICMS refresher training for participants before each tabletop ERE be helpful?
  - Yes, this would be very helpful and should occur.
- 3. Is there a need for tracking team progress of ASR2 if there are no USAR worksites? If so, how and at what level?
  - Yes, progress tracking may be necessary, as long as it does not overly burden the teams. This IMWG will research options to address.
- 4. In using ICMS, what gaps do you face?
  - Data sharing, importing and exporting data, PII/PHI
- 5. Do we collect too much, not enough or the wrong elements of data?
  - Building assessments for engineers may be necessary on a separate dashboard
  - Elements in forms should be evaluated for need


