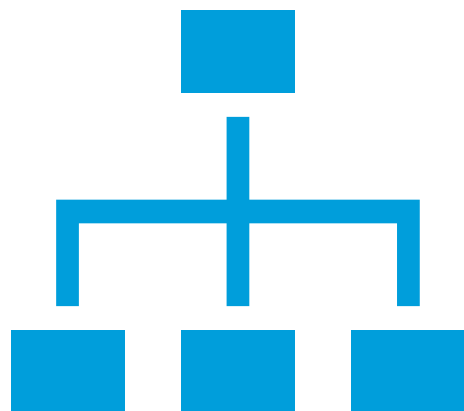

- The humanitarian field has faced challenges during the past months. The resources available to us are stretched thin, yet the needs continue to grow. Many organizations have been forced to make difficult decisions, scaling back essential programs or delaying critical aid.
- INSARAG as a Network will remain steadfast in our commitment but will also need to adapt to shifting conditions.
- OCHA as an organization is scaling down, and so is the Secretariat. The capacity for the Secretariat to participate in classifications, meetings and other activities has and will continue to change, putting higher demands on the network.
- As a network, we must stay together, as INSARAG's role is more critical now than ever.

ISG 2025 Summary Update

- The Secretariat would once again like to thank everyone who participated in the INSARAG Steering Group meeting in Geneva in March.
- During this important meeting the ISG endorsed several items. Among others, an extension of the Search and Rescue in Flood Response Working Group was endorsed, a new model of funding for the ICMS was endorsed in principle, and the Governance Review reached a conclusion on several areas of Annex I, and on all recommendations of Annex II.
- Three Thematic Areas of Annex 1 are still under process - Area 2: Decision-Making Mandate, Area 3: Accountability and Compliance and Area 7: Localization – that will be further discussed today.

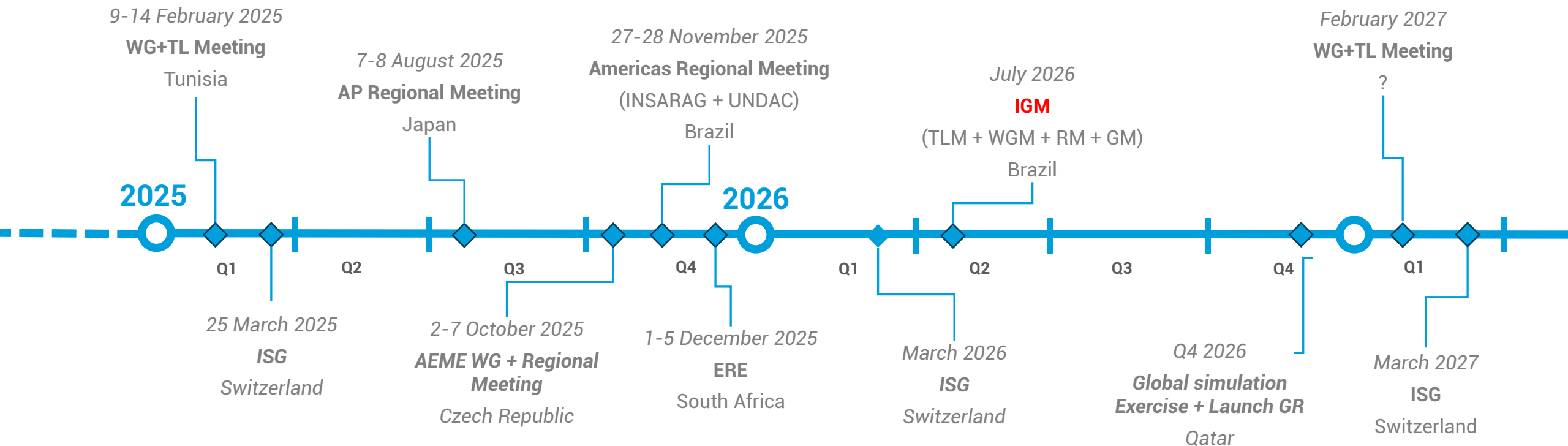

The event was facilitated by the INSARAG Secretariat with 81 participants attending in person and 59 participants attending online, representing 34 countries and 9 Organizations, plus observers. INSARAG Coordination Management System (ICMS)



AEME Feedback on ICMS

- Funding model endorsed at INSARAG Steering Group (ISG) on 25 March 2025, and further by Regional Chairs
- A fundraising drive is ongoing within the INSARAG network to support a sustainable funding model
- Teams have received a message from the IM Working Group to proceed with the payment.

Sustainable Funding Model ICMS

The 2025 ISG acknowledged the need for a new model of funding to ensure continued development and operational effectiveness for ICMS 3.0 and, in principle, endorsed the presented funding proposal.

The funding proposal includes each team covering the cost of a five-year ICMS use for EUR 7,500, or EUR 1,500 yearly for five years, covering access, maintenance, training, and support.

The license fee will cover:

- Full access to ICMS and its features
- Development of new versions and maintenance of ICMS
- Online training modules
- Development of Face-to-face training courses
- Operational support from the IMWG Technical Support Team during major deployments

In order to facilitate the license fee payment, NED-01 has been asked by the Secretariat to act as Treasurer of the funds and will coordinate the whole payment process.

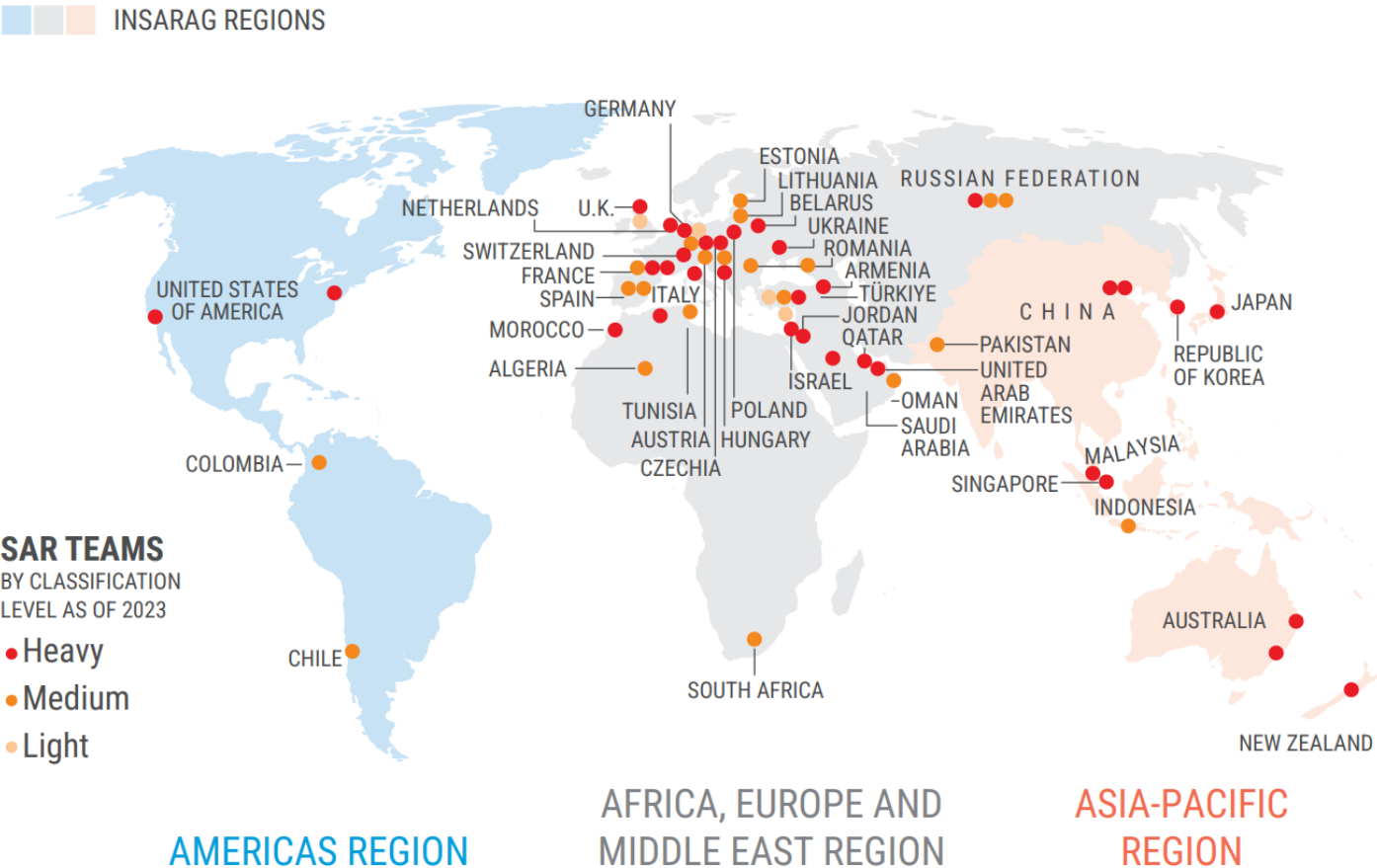

The Strategic Plan of the International Search and Rescue Advisory Group (INSARAG) presents the vision, overarching goals and strategic objectives of the network, endorsed by its Global and Regional chairs, for the period 2021-2026.

Our Vision and Mission

OUR VISION is to save lives by promoting efficiency, enhanced quality and coordination amongst national and international Urban Search and Rescue (USAR) teams based on adherence to common guidelines and methodologies.

OUR MISSION is to prepare for, mobilize and coordinate effective, principled and flexible international USAR assistance in support of countries affected by collapsed structure emergencies, and to actively support capacity-building at the international, regional, national and local level to ensure a localized and coherent response to emergencies.

Our Mandate and Role

OUR MANDATE is recognized and supported by the United Nations General Assembly Resolution 57/150 of 16 December 2002 on “*Strengthening the Effectiveness of International Urban Search and Rescue Assistance*” and recalled in several further declarations such as the INSARAG Hyogo Declaration (2010) on the “*Recognition and Strengthening of International Urban Search and Rescue Operational Standards*” and the INSARAG Abu Dhabi Declaration (2015) on “*Strengthening Preparedness and Response Standards of National and International Urban Search and Rescue Operations*”, adopted at the first and second INSARAG Global Meetings, that provide renewed impetus and guidance for our work ahead and put special emphasis on the need for national capacity building. Experiences in recent emergencies and other related platforms such as the World Humanitarian Summit in 2016 have recalibrated our focus and resources towards strengthening the national capacity.

OUR ROLE is to:

- Develop and promote globally recognised standards for USAR assistance, coordination methodologies and tools.
- Mobilize and coordinate information exchange protocols between relevant stakeholders for rapid response.
- Promote cooperation and share experience with partners at local, national, regional and international levels with National Disaster Management Agencies from Member States, Non-Governmental Organizations (NGOs), the private sector, academia and other relevant networks.

Our Values and Operational Norms

- **Adherence to common standards and methodology:** Members of the INSARAG network commit to adhere to the INSARAG Guidelines and methodology as globally accepted and independently verifiable minimum operational standards and procedures, based on experts’ knowledge and evidence-based experience. The INSARAG network continues to develop these standards and procedures through shared and continued learning.
- **Inclusiveness:** INSARAG brings together governments, governmental organisations, NGOs and disaster preparedness and response professionals. INSARAG particularly encourages disaster-prone countries to join the network, as well as any country or organisation with USAR response capacity. INSARAG emphasises the importance of gender awareness and considerations while working in disaster-affected areas.

The initial Governance review report provides on page 42 that ‘A pragmatic view may say that with limited time to make decisions, consensus should be the objective, but allowances made for when consensus cannot be reached.’ It would appear that the initial questions have been amended during the consultation process, which has led to differing views and results within the network.

REVISED QUESTIONS AND EXPLANATORY NOTES

In view of the differing views, the following amended questions are recommended in going forward:

2.1 Consensus is reached when all members have agreed to adopt a proposal. Members can agree to adopt a proposal, but still have reservations.
2.2 If consensus cannot be reached, the issue will be deferred to the Global Chair and the Regional Chairs

The INSARAG Guidelines are silent on ramifications for non-compliance, including who or which organization within the network is empowered to ensure compliance. The status of the non-legally binding INSARAG Guidelines cannot be unilaterally changed by its members under international law. As such, and in view of the fact that a univocal global position has not been achieved, the Secretariat suggests excluding this area from the Governance Review.

The Americas Region concluded that announcing priority or vulnerable countries could have domestic political implications. Since gaps are already being identified and addressed bilaterally with appropriate assistance, there is no need for regional groups to map vulnerable countries according to the Americas Region. As a result, and in the absence of a univocal global position, the Secretariat suggests applying a regional approach to this area, which is in line with the current practice within the network. Consequently, this area is recommended to be excluded from the Governance review.

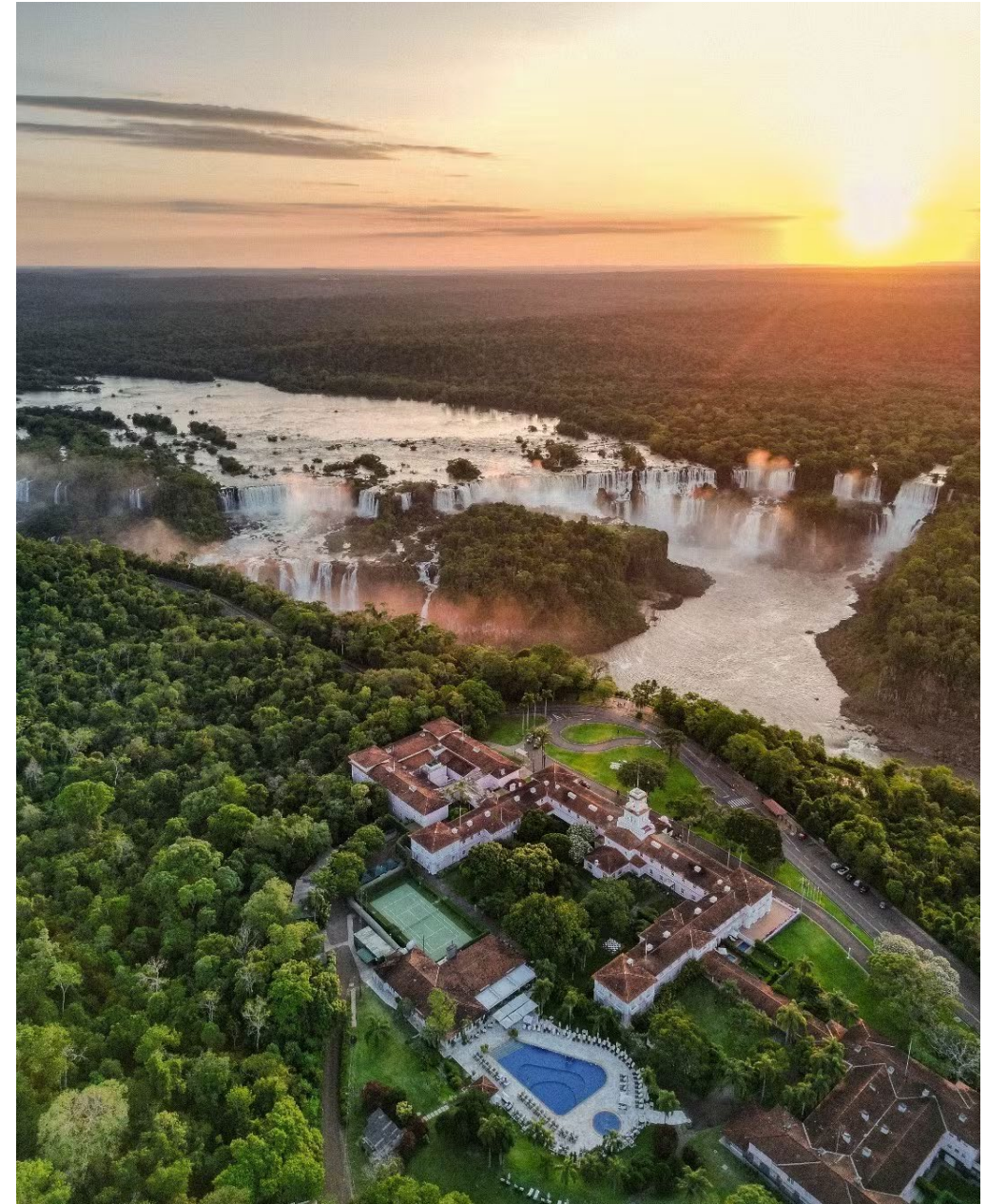

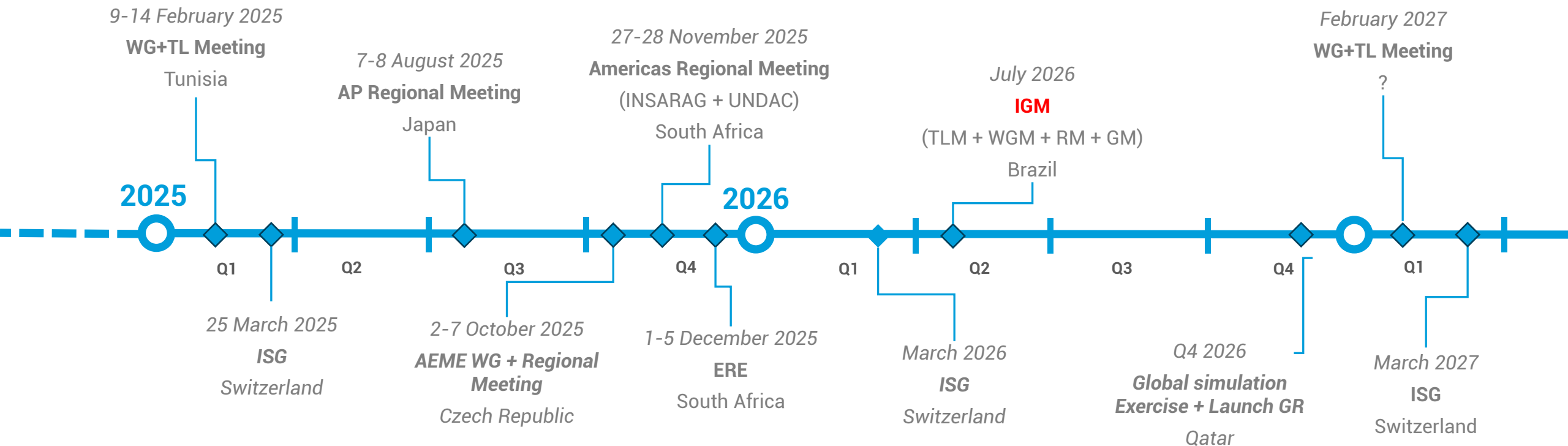
- Flood response mechanisms in EU already robust
- National level capabilities provided to the EU for deployment
- Some teams in AEME already have flexible response capabilities
- Not always the same capability in the USAR teams to provide Flood Rescue.
Separate responsibility and capability.
- INSARAG should do more research on who does what in the humanitarian space and be humble rather than thinking they are going to take over areas that are already being serviced.
- Flood response through INSARAG flexible response is not largely supported in the EU.
- Cooperate with the capabilities in country rather than incorporate into their USAR teams
- Use of existing USAR Team Management and coordination structure for rapid deployment and self sustainability could be complimentary for flexible response
- No planned flexible response activities currently planned for the INSARAG AEME region for 2026

- International simulation exercise under the INSARAG framework (Earthquake Response Exercise) hosted by Lekhwiya at the Qatar Search and Rescue Training center
- Qatar in November of 2026.
- Several teams have expressed interest for the exercise, including Japan, Australia, South Korea, Singapore, Thailand, and Malaysia
- This exercise will bring together regional and international USAR teams, humanitarian actors, and government agencies under a realistic deployment and humanitarian coordination scenario.

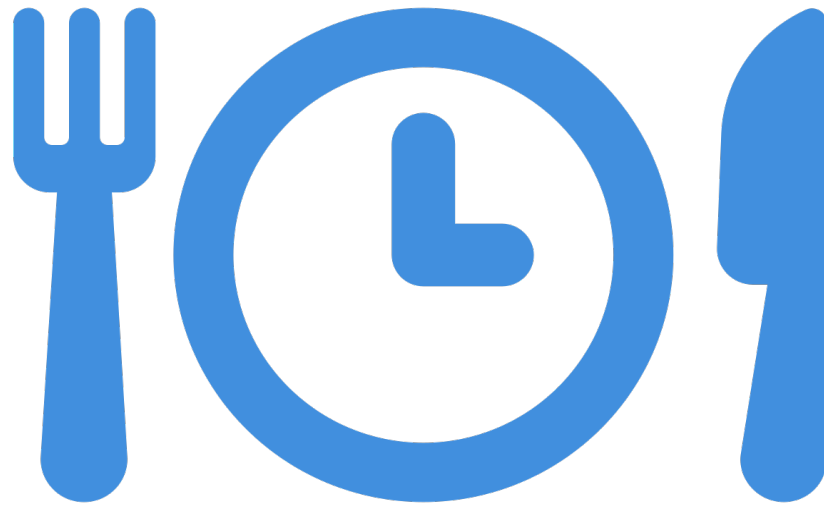

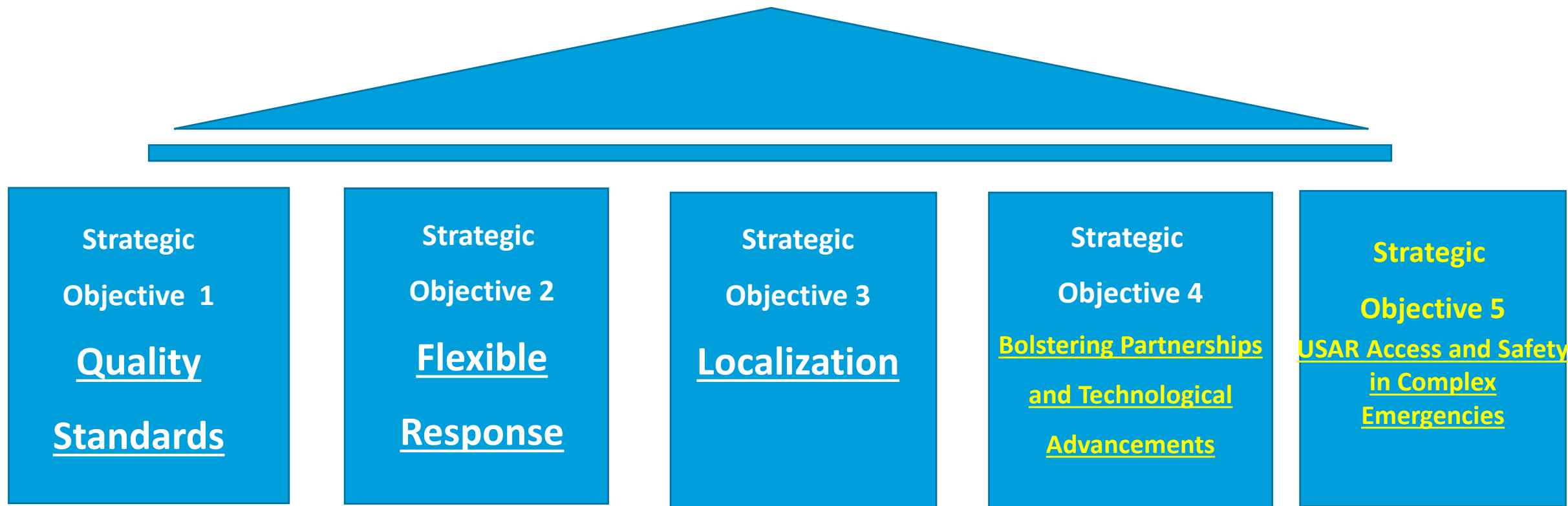

Key Regional Meeting Outcomes and Closing Address

Outcomes of AEME Regional Meeting 2025

- Growth of the INSARAG network continues, with 71 classified teams expected by 2027
- Strong commitment from the AEME region through the strong participation in Working Group, provision of Classifiers and Mentors.
- International Cooperation reinforced through regional and global events (ERE in South Africa, global meeting in Brazil and 2026 Global ERE in Qatar and launch of the new guidelines)
- Strong commitment to further develop the INSARAG methodology (e.g. discussions on Quality Assurance IEC/R proposals, updates to the GL)
- A severe funding crisis affecting OCHA and support to INSARAG activities.
- Importance of providing sustained funding for core INSARAG activities (training) and tool (ICMS).

Outcomes of AEME Regional Meeting 2025

Consultations on AEME Regional Workplan 2026 and the INSARAG Strategy 2026-2030 shows a strong support to the current objectives:

- **Quality Standards:** Continued work on guideline improvements, IRNAP adoption, and bilateral support.
- **Localization:** Support for disaster-prone countries, first responder training; Strong commitment to host courses in the region and provide bilateral support is demonstrated.
- **Flexible Response:** Progress on flood response guidance and tools with opportunities for INSARAG to explore its value for multi-hazards responses.
- **Partnerships:** Considered part of INSARAG DNA but not necessarily need to be set as a Strategic Objective per se in the next strategy
